Camp Goal:

Mercer University Men's Basketball wishes to provide an opportunity through Greg Gary Basketball Camps for your team(s) to compete against quality players, teams and coaches in order to improve your program's ability and team chemistry.

Dates & Times:

Team Camp will be held June 13th-15th (Thursday-Saturday). Games will start each day between 8am-9am continuing through the evening hours as necessary.

Participants:

Team camp will host high school teams (Varsity, JV and Freshman teams) from all sizes from the State of Georgia and the Southeast. The number of teams involved allows teams to play varied levels of competition.

Athletic Trainers:

A Mercer University athletic trainer will be on site to handle any medical issues which may arise.

Facilities:

Mercer University Center (Five full sized, air conditioned, courts)
Additional local courts will be utilized as necessary. Directions will be provided.

Transportation:

All Mercer facilities are within walking distance. Shuttle service will be provided to alternative locations for coaches/teams as necessary.

Food & Lodging:

For boarding teams, lodging will be held in one of Mercer's air-conditioned dorms. Dorms are within walking distance to both courts and the dining hall. Many meals will be served court-side. Boarding teams have meals and lodging included in costs. Meals are not provided for commuting schools but may be purchased in advance.

Games, Officials & Rules:

Unless a coach requests otherwise, each team is guaranteed 3 games on the 1st day, 3 games on the 2nd day and 2 games on the 3rd day of team camp. GHSAA officials will be utilized to the extent possible. All games will follow GHSAA game rules, with minor exceptions, to mirror regular season games.



Scheduling:

Scheduling for team camp will be completed the week prior to camp start date. If you have special scheduling requests, please contact our team camp director, DJ Byrd at Byrd_DJ@Mercer.edu.

Pricing:

Please refer to the team camp brochure for all updated pricing information.

Other Notes:

- Boarding rates include lodging and meals
- Commuters can secure lunch meals with camp but this must be requested at the time of registration.
- Payment of your deposit secures your team(s)' spot at camp. Balance owed can be paid upon arrival.
- Coaches must complete a witnessed 2019 Mercer University Facility Usage Form/Greg Gary Basketball Camp Release and Waiver of Liability at check in for each and every participant. A parent/legal guardian MUST sign these forms for each participant.
- Registration ends on June 5, 2019.
- Please do not bring valuables to team camp. Greg Gary Basketball Camps and Mercer University are not responsible for lost/stolen items.
- Please make team payments in the form of 1 check whenever possible. We request that parents write checks/pay each coach and that coach then write one check for camp whenever possible.
